What personal info do we hold?

We may hold the following information

Expressair holds some of this information on a secure server. The information can be accessed by office staff employed by Expressair and by Coda Commerce Ltd who manage our dispatch operating system. Remote access is made via registered mobile security passwords.

Our Accounts software is held on a password controlled computer based in our office, it can not be accessed remotely. All programs are password protected. Access to our office is restricted by way of door code entry systems and lock and key. The premises are alarmed.

When do we collect data?

- When an account is opened
- When you use our services
- When you contact us

This information does not contain any special type of information or location-based information, other than we hold Business name, address, email and telephone numbers of customers.

How do we use information held?

- To identify you, as our client and your account held with us.
- To invoice you and allocate payments using this information.
- To contact you regarding future business or any current deliveries we are undertaking for you.
- To conduct credit checks and administer payments
- To resolve queries and complaints
- To recover debt
- To comply with our legal obligations

Expressair understand the requirement of confidentiality, integrity and availability of the data it processes. Delivery data will be used for HMRC Customs and delivery agents as required to process export/import/deliveries. The information is retained in line with HMRC (and overseas Customs agencies as applicable) requirements and destroyed when no longer required by guidelines. Delivery data is held securely and processed as required.

We hold no third party links on our website www.expressair.co.uk. We do not use Google ads on our website www.expressair.co.uk.

Expressair will hold the data as necessary to comply with the laws that apply to the business as set out by the relevant Customs Authorities. Expressair will notify you of any data breaches.

Expressair only acts on the written instructions (via manual consignment notes, manifests, email or data transfer) from customers and use that data to accomplish deliveries of goods including UK, customs and destination countries.
